Mulching – all beds have been “turned”. This means that all areas containing plants, trees and shrubs have been raked of leaves and debris and the mulch put down last year turned over. This will provide a uniform look to the entire community for at least 1 more year. Residents need to contact the Board or ACM before putting any type of mulch on common area planting beds.

Damaged sod - Sod that has been damaged by pets will be replaced at the owners expense. Landscape Concepts is currently surveying the damage from last year and will be making a recommendation to the Board for replacement.

Mowing—Fox Ridge will be mowed every Friday this season. Any homeowner property on common ground (grills, toys, dog tethers, etc.) must be removed. Any damage caused to the lawn maintenance equipment due to items left on the lawn will be charged back to the resident.

Watering—We have been lucky so far this year not having to water due to the heavy rains. However, please remember that it is the resident's responsibility to water their part of the common area around their unit. This will be particularly important when blanket seeding for the grass.

Appearance—For those residents that have been planting flowers, installing landscaping lights and in general making their units look nice : **A VERY BIG THANK YOU FROM THE BOARD**

Residents and homeowners walking their pets need to pick -up after them **immediately**. Leaving pet refuse in the common areas is extremely inconsiderate to all homeowners. The pet owner will also be responsible for cleaning up the limited common area outside the sliding doors of their unit if they allow their pets to go there. For those people that pick-up every time—THANK YOU !!!

Deck Staining Project - Those homeowners whose address is listed below can expect to have their balconies/decks powerwashed and stained this spring. A notice will be posted on your front door a couple of days before any work is to begin. This will be a two year project with approximately 1/2 of the decks done each year. The homeowner will need to remove all items from their balconies/decks and remove all (nails, hooks, planter hangers, flag poles) items attached to the deck.

P.S.—don't' forget to close and lock your sliding glass windows when they powerwash.

REMINDER

Garbage Cans—garbage cans need to have a tight fitting lid and have the owners address on the can. Grills—Charcoal grills should not be used in the garage or under the porch overhang. Gas grills used on the front porch should be far enough away from the siding so as not to warp it. Both of these recommendations seem common-sense but improper use has been witnessed within the community. Please think safety when grilling outdoors.

Bee/Wasp Spraying—The wasp nests have been removed from all buildings and sometime in May a company will come out and spray all buildings to try to keep the wasps from coming back and constructing new nests.

Over the past several years, it has been my privilege to represent you on the County Board and Forest Preserve Board where I have been President for the past 7 years. It is always helpful to hear issues that are important to you and to have the opportunity to help. One way for me to communicate with you (in a cost effective way) is through my periodic email newsletter. Subjects such as: weather updates; current road improvements or traffic issues in general; flooding; neighbor problems; drinking water contaminations; zoning; land acquisitions; trail connections; senior tax freezes; free prescription drug cards plus fun events that are happening in the area such as free concerts; Civil War Days etc. are all subjects that I cover along with other items I feel you would be interested in. Fox Lake In Bloom— There is a new community group forming in Fox Lake. David Gauger (H.O.A. President) is serving on one of the sub-committees that is charged with cleaning up a section of Route 12 that runs in front of Fox Ridge. He is looking for any volunteers to periodically help clean the Frontage Road from Windsor North to the Frontage Road intersection with Route 12. Vandalism—sometime over the weekend of April 17-18 unknown persons vandalized the sitting bench on the North trail just past the retention pond. It is beyond repair at this point and the Board will decide whether to replace it or not at the next meeting. This is just a reminder that unfortunate incidents happen even in Fox Ridge. Now that the weather is getting nice remember to lock your car every night (especially if you keep your garage door opener in it). Fox Ridge has experienced twice in the past three years a night when unknown persons have entered unlocked cars and taken anything of value. The easiest way to keep this from happening to you (if it ever happens again) is to always lock your car over night.

Association Dues—The Board did not vote to raise the monthly association dues for 2009. These fees are used for many things that need to be done in the sub-division. We are trying to make due this year using last year's budget. This is one of the reasons that some of the short range plan projects were put on hold this year. We are looking forward to re-instating some of the short range planned projects next year if we can.

Boat /Trailer Storage— Now that boating time is here, the boat parking restrictions in Fox Ridge need to be addressed again. There is no boat or trailer parking in Fox Ridge at any time. If a resident parks a boat or trailer on the property they should expect to have it stickered and called in for towing within 24 hours. These rules and regulations will be strictly enforced this year.
